## **CENTERMAC REALTY, INC. DBA CENTRAL FUNDING'S CONSUMER PRIVACY POLICY FOR ITS WEBSITES**

Centermac Realty, Inc. dba Central Funding understands that privacy and data security are vital concerns to our users. We respect their privacy and recognize the importance of their personal and business information. We are committed to protecting their information through our compliance with this Privacy Policy.

When a consumer visits our website or establishes an account on our websites, we may collect certain information from them. This Privacy Policy describes the types of information we collect when a consumer visits our websites or subscribes to our services (collectively, our "Services") and our practices for using, maintaining, protecting and disclosing that information.

Kenny Tan is the Chief Executive Officer(CEO) designated to coordinate the program. These policies and practices are implemented to protect their information.

### What Information Do We Collect?

We collect several types of information from and about users of our Services. This information includes the following:

Information Consumers Provide to Us. The information we collect on or through our Services may include:

- Information they provide when they register with us and subscribe to our Services. This information includes their name and email address, and may also include their phone number and physical address.
- Information they provide to respond to a survey.
- Records and copies of their correspondence, including email address, if they contact us.
- Details of transactions they carry out through our Services.

We do not transmit their information to other users of the Services or third parties.

Information We Collect Automatically. As they navigate through and interact with our Services, we may use automatic data collection technologies to collect certain information about their equipment, browsing actions and usage patterns, including:

- Details of their visits to our Services, including the resources that they access and use on the Services.
- Information about their computer and internet connection, including their IP address, operating system and browser type.

We also may use these technologies to collect information about their online activities over time and across third-party websites or other online services (behavioral tracking). See below for information on how they can opt out of behavioral tracking on our website and how we respond to web browser signals and other mechanisms that enable consumers to exercise choice about behavioral tracking.

The information we collect automatically is statistical data and does not include personal information. This data helps us to improve our Services and to deliver better and more personalized features to the consumers, including by enabling us to:

- Estimate our audience size and usage patterns.
- Store information about their preferences, allowing us to customize our Services according to their individual interests.
- Speed up their searches.
- Administer a contest, promotion, survey or other feature of our website.
- Recognize them when they return to our Services.

The technologies we use for this automatic data collection may include cookies. A cookie is a small file placed on the hard drive of a computer. Consumers may refuse to accept browser cookies by activating the appropriate setting on their browser. However, if they select this setting, they may be unable to access certain parts of our Services. Unless they have adjusted their browser setting so that it will refuse cookies, our system will issue cookies when they direct their browser to our Services.

Children Under the Age of 13. Our Services are not intended for children under 13 years of age. No one under age 13 may provide any personal information via our website or register for our Services. We do not knowingly collect personal information from children under 13. If they are under 13, they should not register on our website, make any purchases through our website, use any of the interactive or public comment features of

our website or provide any information about themselves to us, including their name, address, telephone number, e-mail address or any screen name or user name they may use. If we learn we have collected or received personal information from a child under 13 without verification of parental consent, we will delete that information.

#### How Do We Use Their Information?

We use information that we collect about them or that they provide to us, including any personal information:

- To present our Services and its contents to them.
- To provide them with information, products or services that they request from us.
- To fulfill any other purpose for which they provide their information.
- To provide them with notices about their account.
- To carry out our obligations and enforce our rights arising from any contracts entered into between them and us.
- To notify them about changes to our Services or any products or services we offer or provide through it.
- To allow them to participate in interactive features on our Services.
- For the purpose of aggregated statistical analysis of how they and others use our website and our Services.
- For developing and marketing other services, provided no personal information is disclosed.
- In any other way we may describe when they provide the information.
- For any other purpose with their consent.

We may disclose personal information that we collect or they provide as described in this Privacy Policy:

- To fulfill the purpose for which they provide it.
- For any other purpose disclosed by us when they provide the information.
- With their consent.

We may also disclose their personal information:

- To comply with any court order, law or legal process, including to respond to any government or regulatory request.
- To enforce or apply our Terms of Service and other agreements, including for billing and collection purposes.
- If we believe disclosure is necessary or appropriate to protect the rights, property, or safety of CRI, our customers or others. This includes exchanging

information with other companies and organizations for the purposes of fraud protection and credit risk reduction.

Other than as described above, we will never provide the information to anyone for any purpose under any circumstances.

#### What Are Their Choices About How We Use and Share Their Information?

We strive to provide them with choices regarding the information they provide to us. We have created mechanisms to give them the following controls over their information:

**Tracking Technologies.** They can set their browser to refuse all or some browser cookies, or to alert them when cookies are being sent.

**Promotional Offers from CRI.** If they do not wish to have their contact information used by CRI to promote our services, they can opt-out by sending us an email stating their request to [centralfundingca@gmail.com](mailto:centralfundingca@gmail.com). If we have sent them a promotional email, the email will have an "unsubscribe" feature that will allow them to opt-out of receiving future email distributions.

#### How Can They Access and Correct Their Information?

They may send us an e-mail at [centralfundingca@gmail.com](mailto:centralfundingca@gmail.com) to request access to, correct or delete any personal information that they have provided to us. We cannot delete all of their personal information except by also deleting their user account. We may not accommodate a request to change information if we believe the change would violate any law or legal requirement or cause the information to be incorrect.

Access to and use of information provided via the Services, including User Content, is governed by our Terms of Service.

#### How Is Their Information Kept Secure?

We have implemented reasonable measures designed to secure their personal information from accidental loss and from unauthorized access, use, alteration and disclosure. All information they provide to us is stored on our secure servers behind firewalls and will be backed up on at least a weekly basis. Any payment transactions will be encrypted using SSL technology.
